Important Dates & Deadlines:

- Tryout Applications Due: Sunday, April 13, 2025
- Preliminary Video Submissions Due: Monday, April 21, 2025, by 12:00 PM (Noon) MST (Don't wait until the last day to submit!)
- Semifinals & Finals (Invite Only): May 9-10, 2025
- New Team Meeting (via Zoom): May 13, 2025, at 5:00 PM MST

Spirit Leader Tryout Material:

All video submission material will be emailed to the address provided in your application on **April 14**, 2025. Video submissions are due by **April 21**, 2025.

New material for the semi final evaluation will be sent via email on **April 28**, 2025. All candidates advancing to this round will receive a link to access the tryout material.

Female attire: All black sports bra and spandex, hair down, Game day makeup. Athletic/Cheer Shoes.

Male attire: Clean cut hair style, <u>no</u> facial hair. All Black athletic T-shirt and gym shorts. Athletic/Cheer Shoes.

Tryout Fee:

- A \$50 tryout fee (for semifinals only) will be collected at registration on May 9th.
- CASH ONLY—no other forms of payment will be accepted.

CHEERLEADING TRYOUT PROCESS

Tryouts

Tryouts will begin with a first-round video submission. Emails will be sent on April 28th to those advancing to the semifinals. The semifinal and final rounds will take place over a two-day weekend evaluation and cut process on May 9th and 10th. All material will be emailed via a Google Drive link two weeks prior to semifinals.

Material will be evaluated in person, and cuts will be made throughout the weekend until approximately 10-18 female athletes and 5-12 male athletes are selected.

Female candidates will be assessed on dance ability, tumbling, stunting, and overall personality/crowd engagement.

Male candidates will be evaluated on attitude, willingness to learn, and potential—no prior cheer experience is required.

All finalists will participate in an interview portion as part of the selection process.

CHEERLEADING REQUIREMENTS & EXPECTATIONS

Summer Workouts

- Choreography will be required to be learned over the summer with video submissions
- Summer workout expectations will be given at the mandatory new team meeting May 13th.

The ASU Spirit Squad encompasses well rounded individuals of both good character and game day cheer ability. Due to their high visibility within our community, we are looking for those that best represent the University in a positive way. How well you work with our coaches, each other, and receive corrections will be highly considered at tryouts. In support of ASU athletic games and other appearances, commitment to a full year of participation is absolutely mandatory. ASU Spirit Squad cheers at all home Football, Hockey, and Basketball Games. Candidates must be committed for the entire duration of the season starting in April at tryouts, summer workouts, camp, football, hockey and basketball Season. (July - March)

Dance: ASU Spirit Squad has a NFL, NBA pro style of dancing for games. Prior dance experience is <u>not</u> required but will be the style of sideline and half time routine for tryouts. **Yelling loud with** natural collegiate cheering expressions, sharp motions and proper motion placement is very important.

Tumbling (Females only): A clean consistent standing back tuck, cartwheel tuck and running multiple back handsprings to a tuck is required to make the team. Increased level additional standing and running tumbling may increase your chances of making the team. We suggest practicing your standing tuck with poms. Jumps are not performed.

Stunts: This season athletes will try out for <u>one</u> stunting position. Male athletes are only eligible for coed stunts.

All -Girl Requirements

- Quick toss to extension.
 - Extended liberty, heel stretch, arabesque, etc. Extension bump in go liberty & clean Full up

• All-Girl Preferred Stunts:

- -Low to high, tick tock
- -Low to high, full around
- -High to high, full around
- -Elites/ Inversions Hand & hand, BHS up, Round off up, Front handspring up, Rewind, etc.
- -Dismounts front flip, back prone, double downs preferred

Coed MALE Stunting Requirements:

- Toss hands
- Safe & secure pop offs
- Toss Chair

Coed Preferred Stunts:

- Toss platform, heel stretch/ lib
- -Toss Extension
- -Toss heel stretch/lib
- -Toss cupie
- -Full up
- -Hands full around
- -High to high full around
- -Elites/ Inversions Hand & hand, BHS up, Round off up, Front handspring up, Rewind, etc. Dismounts front flip, back prone, double downs preferred

Coed FEMALE Stunting Requirements:

- Toss chair
- Toss hands
- Toss bump & go, extension
- Toss extension
- Toss platform, Liberty
- Toss platform, Heel stretch
- Safe & secure pop offs

Other: While talent is important, it is not the only factor to be considered. We are also looking for those that exude strong leadership qualities, confidence, hard work ethic, willingness to try new things, good response to correction, positivity, respect for everyone, voice inflection, and ability to engage an audience.

We do not have a weight or height restriction as size ranges fluctuate from year to year, however candidates must possess sufficient physical fitness and proper training to execute all required skills.

Candidates **must be** accepted to or enrolled at Arizona State University, Fall Semester 2024.

Upon making the team, members must be enrolled in the Band Course associated with the Spirit Squad for BOTH semesters.

Must have a minimum 2.5 semester & cumulative Grade Point Average

Maintain Full Time ASU Status (12 credit hours) per semester

INCOMING STUDENTS must provide a copy of your letter of acceptance.

CURRENT ASU STUDENTS must provide an unofficial transcript.

TEAM FEES, FINANCIAL OBLIGATIONS & FUNDRAISING:

o \$200.00 non-refundable team fee will be due upon making the team immediately after tryouts

• Financial Obligations:

o Additional practice apparel/makeup/liners, tights etc. will be required and will be paid by the athlete.

• Fundraising:

o Additional fundraising efforts will be necessary and vary each year. All members will be expected to participate in fundraising/ stunt clinics & camps.
